

MINUTE OF JURY SELECTION

Call for Postdoctoral fellowship
Project ref 223192/A/21/Z

On 25 of May 2023, at 10:00, the selection jury formed by Dr Moritz Treeck, Dr Vera Martins and Dr Maria João Amorim, met to analyse the applications to a Postdoctoral fellowship in the scope of the project (223192/A/21/Z “A systems-biology approach to identify Toxoplasma effectors that co-opt host cell transcription and their function in immune system suppression), funded by the Wellcome Trust.

The call was open from 09th of May of 2023 until 23rd of May of 2023 (10 days). The jury analysed the documents submitted in the applications. The call received 5 applications, one of which was not eligible.
