



## MINUTES OF JURY SELECTION

Call for Postdoctoral Researcher Position Project "HORIZON-EIC-PATHFINDER-101099654", entitled "Real-Time highcontent Super-Resolution Imaging of ES Cell States"

On September 29th, 2023 at 10am, the Selection Panel composed of Dr. Ricardo Henriques, Dr. Hannah Heil and Dr. Bruno Saraiva (panel members) met in order to review the applications under the HORIZON-EIC-PATHFINDER-101099654project, funded by the European Research Council.

The position was open from August 15th, 2023 to September 15th, 2023. The panel reviewed the documents included in the applications. 3 candidate applied and were ranked as follows:

Comments – After conducting a comprehensive review of the applications, the members of the jury were in agreement that, although the candidates had relevant backgrounds and impressive skills, their qualifications did not fully meet the specialized requirements needed for this role at present.
