Call for Master's Research Fellowship Project *S.cerevisiae* Gene Essentiality

At 12 of January 2024 meet, at 16:00, the jury selection formed by Marco Fumasoni, Ana Garona e Mario del Rosario, responsible for analysing the applications to a master's Research Fellowship, in the scope of the project *S.cerevisiae* Gene Essentiality, funded by Fundação Calouste Gulbenkian.

The call was open from 27 of December 2023 until 11 of January 2024. The jury analysed the documents included in the applications found attached to these minutes.

All the candidates were ranked according to the requirements presented in the call, which were described as holding a master's degree in biomedical engineering and having a background in molecular biology, practical experience in microbiology, particularly *S. cerevisiae* manipulation, expertise in flow cytometry, and microscopy, especially live imaging. After considering all applications, the jury convened to interview candidate 1 on January 15, 2024. After reviewing documents and conducting the interview, the jury unanimously decided to recommend candidate 1 based on her scientific background, motivation to pursue a scientific career path in the field of the lab's hiring, and scientific capability to perform the submitted project. Candidate 1 accepted the offer.

Candidate 8 did not present the full documentation requested.

All the candidates were informed of the deliberations of the Jury on 15 of January 2024. If there are no complaints during the 10 working days following the publication of this minute, the decisions herein communicated will be considered as effective.

There being no further matters to discuss, the meeting for which these minutes were drawn up was closed and signed by all the members of the Jury.
