



MINUTE OF JURY SELECTION

Call for Post-Doctoral Research Fellowship (BI-PD) Project "Host-Pathogen Interaction" (CR2023/030/2132)

At 11 of 06 2024 meet, at 10:00, the jury selection formed by Dr Moritz Treeck, Dr Marco Fumasoni and Dr Maria João Amorim, responsible for analysing the applications to a Post-Doctoral Research Fellowship (BI-PD), in the scope of the project "Host-Pathogen Interaction" (CR2023/030/2132), funded by Francis Crick Institute transition grant award.

The call was open from 24/05/2024 until 07/06/2024. The jury analysed the documents in the attached applications to these minutes.

The call received 8 applications that were classified in the following way:

Candidates 3-8 were excluded for not submitting complete applications. After analysing the remaining two candidates, the jury unanimously recommended hiring candidate number 1. This decision was based on his experience in metabolic single-cell heterogeneity and protein multilocalization, mapping the subcellular proteome in human cells with single-cell resolution using high-content immunofluorescence, and conducting CRISPR-based fluorescent protein tagging screens. Additionally, his motivation to develop the project by studying the role of single-cell heterogeneity in the modulation of host responses to Toxoplasma gondii infection was a significant factor in the decision.

All the candidates were informed of the deliberations of the Jury on 13 of June 2024. If there are no complaints during the 10 working days following the publication of this minute, the decisions herein communicated will be considered as effective.





There being no further matters to discuss, the meeting for which these minutes were drawn up was closed and signed by all the members of the Jury.
